### **Assembly Instructions**

- (1) Place the Dolly carefully on a bench with the rim side down.
- (2) Place the Caster on top of the Cross Brace (4) hole pattern.
- (3) Insert one supplied Carriage Bolt through the far side and attach the supplied Washer and Nut (as shown below).
- (4) Repeat step 3 until all Casters are secured to the Dolly.


