Unpacking

General Safety Information

Warning: The Wesco Drum Lifters are intended for specific functions. Please adhere to the following instructions to ensure safe and proper use.

- (1) Maximum capacity 700 Lbs.
- (2) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (3) Only use on Closed Head 55 Gallon Steel Drums

Operating Instructions

- (1) Hang unit on lifting device (hoist, etc.).
- (2) Make sure locking arm of lifter is in open position. If arm is not in open position, pull back clamp bar to set lifter arm open.
- (3) Lower unit until it reaches directly under first lip of drum.
- (4) Secure unit to drum by pushing in clamp bar to lock in place.
- (5) Keep hands clear and raise hoist.
- (6) Move carefully to desired location. Lower again until drum is completely back to ground. Pull back clamp bar once again to disengage lifter from drum.

Warning

- DO NOT use on open head steel drums or any type of fiber or plastic drums.
- Be sure that use of the drum lifter is safe with your equipment.
- Keep hands clear of unit when using.
- Align hoist for a straight line pull centered over load. Do not try side pulls.
- Never leave the drum lifter with a load suspended in the air unattended.
- DO NOT transport any loads over people ever.
- DO NOT attempt to repair when a drum is engaged.
- Periodically check for loose or worn hardware; If found replace at once.
