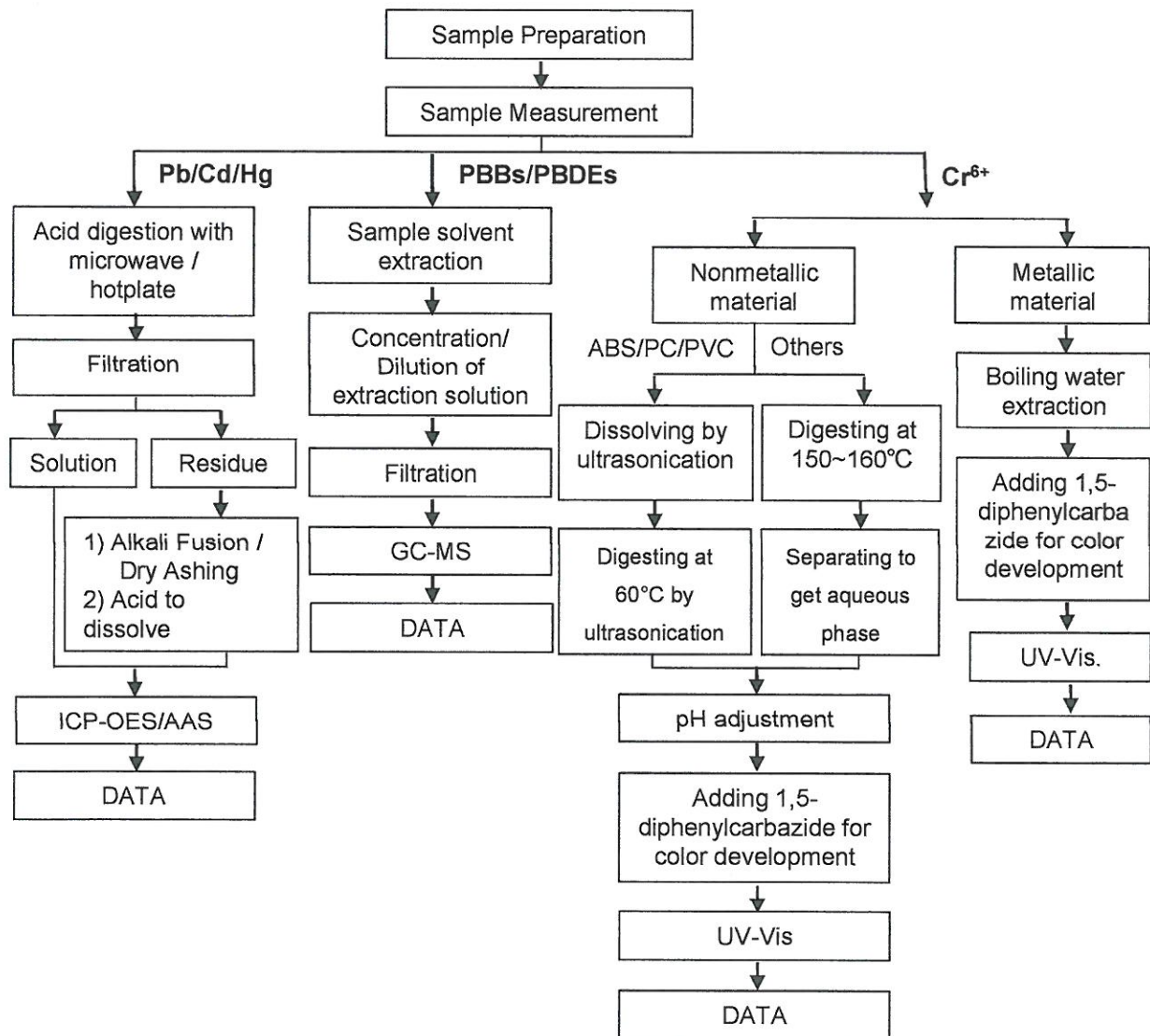

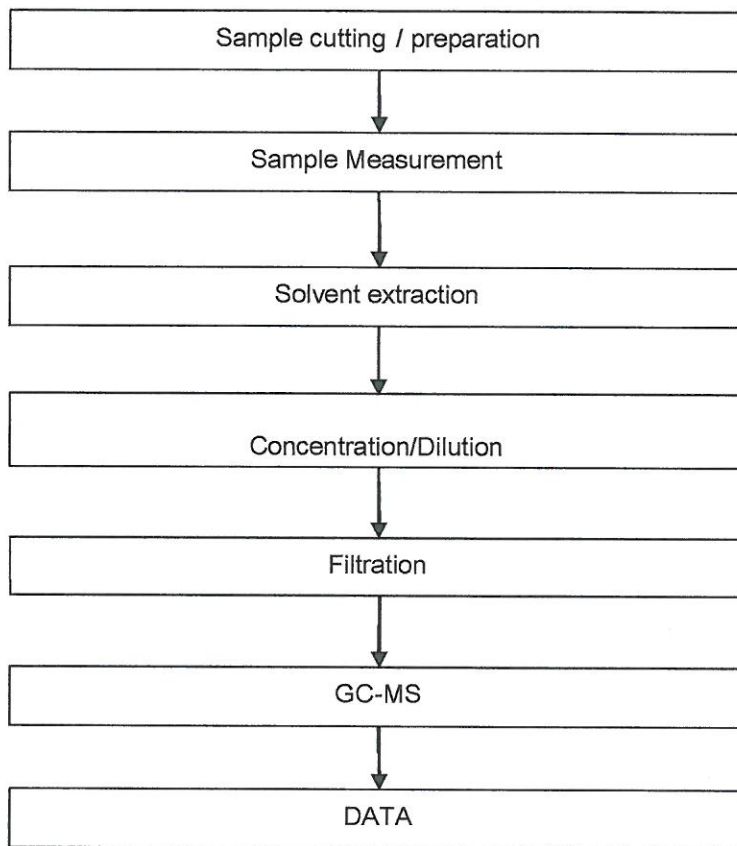

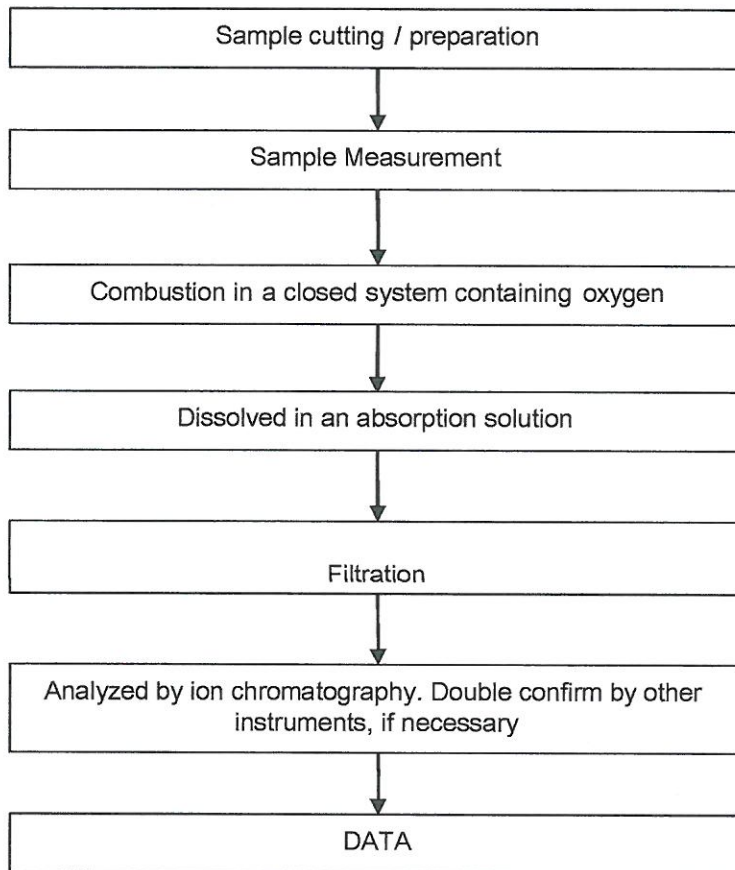

### Halogen Testing Flow Chart



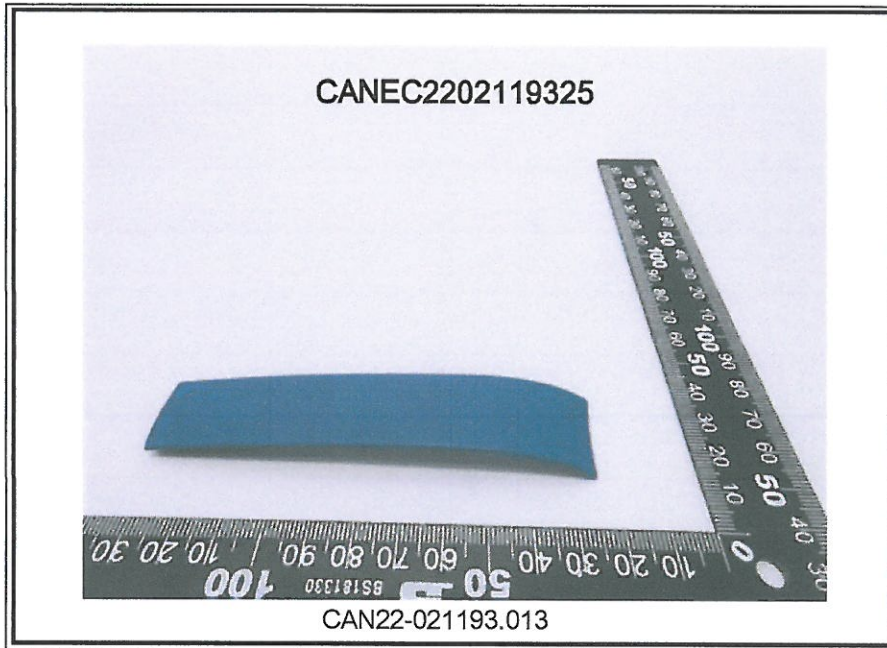
