Certificate of Compliance **Restriction of the use of certain Hazardous Substances (RoHS)**

SIPEL ELECTRONIC SA certifies that, having made full and careful inquiry:

1. All of the materials, components, assemblies, equipment or other products or any parts of such products that it supplies to the industry and that the Supplier has designated as “RoHS compliant” (by the use of product coding, marking or labeling); by inclusion in a listing of compliant products or in any other way whatsoever (the Products) are in full compliance with EC directive 2002/95/EC (the RoHS Directive), EC directive 76/769,EEC (Restrictions on the marketing and use of certain dangerous substances and preparations), as Community implementing such directives (the Applicable Legislation). Please note that our products were RoHS compliant at the time of original production, and no new mfg. part numbers have been assigned.
2. Either the maximum concentration values by weight in homogenous materials for the substances referred to in Article 4(1) of the RoHS Directive that are contained in the Products do not exceed the maximum concentration values of 0.1% in respect of lead, mercury, hexavalent chromium, Polybrominated biphenyls, polybrominated diphenyl ethers, and 0.01% in respect of cadmium OR the use of such substances at higher concentrations is exempt under the Annex to the RoHS Directive 2002/95/EC (in which case the Supplier will identify clearly each relevant product and the exemption that applies to it).
