Your Enquiry: Directive 2011/65/EU and 2015/863/EU (RoHS)

Dear Sirs,

RoHS (Restriction of Hazardous Substances) is an EG-directive with the designation 2011/65/EU dated June, 8th 2011.

The title is:

„Directive 2011/65/EU of the European Parliament and of the Council of June, 8th 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment“.

This EU directive has been transformed into national law with the publication of the electrical- and electronic equipment law – short “ElektroStoffV” dated May, 9th 2013.

Both of the regulations as well as the following changes and updates regiment the usage of hazardous substances in electrical and electronic equipment.

On June, 4th 2015, Delegated Directive 2015/863/EU added 4 further substances to the list of dangerous substances.

As the wheels and castors which you sourced are not related to either electrical or electronic equipment both of the regulations do not have to be applied on our products.

However, since our wheels and castors can be mounted on electrical or electronic equipment, we converted all our products to Chrome-VI-free materials and confirm that all our products have been produced according to the specifications detailed in the regulation, and are therefore RoHS compliant.
