Dear Sirs,

Thank you for your inquiry regarding the EU regulations 2002/95/EG and 2002/96/EG, with regards to ROHS (Restriction of Hazardous Substances) and WEEE (Waste from Electrical & Electronic Equipment).

Wera, as a leading manufacturer of hand tools and power tool accessories, operates a quality management system that is certified in accordance with DIN/EN/ISO 9001:2008.

The EU regulations 2002/95/EG and 2002/96/EG resp. ROHS and WEEE do not apply to the products that Wera manufactures and sells.

For a better understanding please find some important elements of these regulations in the following section.

EU regulation 2002/95/EG - ROHS (Restriction of Hazardous Substances) reduces the usage of certain dangerous parts in Electrical & Electronic Equipment.

As example please find parts of §5 below:

It is forbidden to bring new electrical and electronic equipment to the market which contains more than 0,1 % (based on homogeneous material) of lead, mercury, hexavalent chromium, polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE) or more than 0,01 % ( based on homogeneous material) of cadmium.

EU regulation 2002/96/EG - WEEE (Waste from Electrical & Electronic Equipment) sets the requirements for taking back and recycling of used Electrical & Electronic Equipment. Following product groups are concerned by this regulation:

Technical equipment used in households (washing machines, dish washers, hair dryers etc.)

- IT & Telecom equipment
- Consumer Electronics
- Lights
- Electrical & Electronic tools (such as Drill machines (Bosch, Makita etc.))
- Toys
- Equipment for sports and leisure activities
- Medical equipment
- Surveillance- and control-instruments

As a result, we as manufacturers, and our subcontractors, are acutely aware and are legally obliged not to release such substances, (e.g. lead, mercury, cadmium, hexavalent chromium to name but a few) into the environment in any hazardous form.
